Notice of publication in terms of section 32 (5) of the Engineering Profession Act, 2000 (Act 46 of 2000) ("The Act") of the finding and sanction imposed by a Disciplinary Tribunal at a disciplinary hearing held at Bruma, Johannesburg on 19 July 2007, into the alleged improper conduct of a Professional Engineer.

Nature of Offence:

contravention of rule 2 (f) of the Rules of Conduct for Registered Persons promulgated under Board Notice 107 of 1997 Government Gazette number 18454 of 28 November 1997.

Punishment:

1. Payment of a fine in the amount of R5 000-00 (Five Thousand Rand) and,
2. A suspension of six months. The suspension is suspended for two years on condition that
 - 2.1 The Respondent is not found guilty of improper conduct within the period of suspension; and
 - 2.2 The Respondent attends a course on site investigation at his cost and completes such course within the period of suspension.
