Notice of publication in terms of section 32 (5) of the Engineering Profession Act, 2000 (Act 46 of 2000) ("The Act") of the finding and sanction imposed by a Disciplinary Tribunal at a disciplinary hearing held at Durban on 09 May 2007, into the alleged improper conduct of a Professional Engineer.

Nature of Offence:

Guilty of contravention of rules 2(d) and (f) of the Rules of Conduct for Registered Persons promulgated under Board Notice 107 of 1997 Government Gazette number 18454 of 28 November 1997.

Punishment:

1. The Respondent is ordered to pay a fine in the amount R25 000 (twenty five thousand rand) in total being R12 500 (Twelve thousand five hundred rand) per count.
2. The payment of the fine is to be done in installments of R5000 (five thousand rand) per month and the first payment is to be done on or before 07 June 2007.
