**Guilty** of contravention of Rules 3(1)(a) and 3(5)(c) of the Rules of Conduct for Registered Persons promulgated under Board Notice 15 of 2006 Government Gazette number 28605 of 17 March 2006.

**Punishment:**

Payment of a fine towards the Council , in terms of the provisions of Section 32(3)(a)(ii) of the Act in the amount of R10 000 (Ten Thousand Rand), in respect of each charge of the charges of improper conduct, thus R20 000 (Twenty Thousand Rand) in total.
